- 1. Call to Order Mayor Davis sounded the gavel and called the meeting to order.
- 2. Prayer Commissioner Edwards offered prayer.
- 3. Pledge of Allegiance The pledge was recited.
- 4. Roll Call With all members in attendance except for Commissioner Washington the Mayor suspended roll call and a quorum was declared. Mayor Davis announced that Commissioner Washington would be joining the meeting as soon as possible.

#### 9. 2007-2008 Snow Hill Town Council Strategic Goals and Objectives –

Commissioner Thomas shared the issues that were discussed at the WNCT-TV community forum that was held in Snow Hill. Mr. Clark led the brainstorming session and offered tools to help share ideas. The Council shared their ideas and each idea was grouped into a main category.
