## **2. ETJ Boundaries**

Commissioner Wilkes stated that she would like to see the cemetery expansion completed. Discussion was held on a possible dog park due to the relatively small cost involved. The only viable location at this point would be near the boating access area on Mill Street. Hill reported that to begin the sidewalk project, an engineer would need to draw plans, obtain an encroachment agreement from DOT, and compile a cost estimate. He feels that the project would be around \$35000 based on past work. Hill
